FANNIE JAMES PIONEER ACHIEVEMENT AWARD

Established in 2003, this award recognizes the achievements of individuals or organizations that have contributed to preserving and sharing the history of Palm Beach County's pioneering days. This contribution should enrich Palm Beach County residents for generations to come.

The award honors and is named for Fannie James, an African American pioneer who served as the first post-mistress of the Jewell Post Office, which was open from 1889 until 1903. The area is now known as the City of Lake Worth.

GUIDELINES FOR NOMINATIONS

Who may nominate? Anyone interested in Palm Beach County history may identify an individual or organization that they believe is an appropriate candidate, excluding an organization of which they are an officer, member, or employee. Nominations must be submitted on forms provided by the HSPBC, and anonymous nominations will not be accepted.

Who is eligible for nomination? The goal of this award is to recognize individuals or organizations for their contributions to the history of our county, those that have worked to preserve, promote or enrich our history for future generations. Individuals must live in Palm Beach County, and organizations must serve Palm Beach County.

How many nominees will be honored with the award? Generally, the award goes annually to a single individual or organization. However, if circumstances warrant, more than one individual or organization may be honored.

Confidentiality- Nominations for this award will be made through a public nomination process. Those making nominations should not inform nominees that their names have been submitted for consideration. All nominations remain confidential property of the Historical Society of Palm Beach County.
